Hi Jackie -- I'm still waiting to hear back from you. I haven't given up hope.

We can talk however you want: in person, phone, Skype, text, with your lawyer present or anyone else you want; however you want to do it is fine by me. But I'm speaking to more and more people (as are others in the media), and as I mentioned in my text earlier, the differences between their stories and yours are raising questions that have put the magazine in a difficult position. We're facing the possibility of retracting the article, based on the idea that we can't stand by the things you've said. But I'm still hoping there's an explanation for the questions being raised, and that you can answer them. Here are some examples:

You told me you texted Ryan on my behalf over the summer, asking him to speak with me for the article. He says you didn't. Did you? If not, why did you tell me you did?

Ryan says no conversation about the article ever happened at Cook Out in September – that in fact, the last time he saw you, which happened to be at Cook Out, was in the spring. Is that true?

If not, why did you tell me otherwise?

You told me you didn't want me to speak with Ryan, Alex and Kathryn because of the harsh way they all perceived you or treated you after your assault. What was the real reason you didn't want me to talk with Ryan, Alex and Kathryn?

Was it because you stopped being friends with them for various reasons – because Ryan had rejected you, or because you had a falling out with Alex and Kathryn - and you didn't want that information to come out?

Was it because, according to them, you'd told them a different account of what happened the night of Sept 28, 2012?

Did you tell your friends the night of September 28, 2012 that you'd been forced to perform oral on a bunch of guys?

Did you tell that same account to your roommates a few months later?

Why did your story change?

What happened the night of the 28th?

Who were you out on a date with that night, if anyone?

Did you tell Kathryn and Alex you were going on a date with a third year in one of your classes named Haven Monahan?

Why did you give me and other friends the name **and other friends** as the name of your date?

Ryan, Kathryn and Alex say the night of the 28th, you met them not on a streetcorner on Madison (near the fraternities), but by the dorms on Alderman Road. Is that true?

They also deny that any conversation ensued about the social price of reporting your rape. They said that there was only talk between Ryan and Alex of whether you should go to the police – and that Kathryn was out of earshot, at your request. Is that true?

You told me that your attack left you with a "pulverized" face, including a black eye, a bruised right cheekbone and a split lip. But four people say that in the two weeks after your assault, you had no visible injuries that they can recall. How can you account for that?

You also told me "all" of your friends have asked about the scars on your back - but none of your friends I've spoken with have ever seen scars on your back, including your boyfriend (If you recall, he said this when we were at dinner in September.)
Can you give me an example of someone who's seen them, who I can talk to?

You told me that after September 28th you became an "emotional basket case" and barely left your dorm. But your friends say you continued to act fairly normally, and that your depression seemed to begin in November. Can you account for that?

Was your depression because, as it's been suggested, Ryan rejected you?

Ryan and Alex tell an elaborate story about them texting with a classmate who you said had a crush on you, "Haven Monahan," during the month of September 2012. They now suspect Haven was you. What do you say to that?

They also sent me an email from Haven to Ryan, sent on Oct 3, 2012, that included a love letter to Ryan. Ryan says that you confessed that you had written the letter. The entire thing is super-strange. Can you help me understand it all?

Did you really reach out to on my behalf? Did you really have the conversations with her that you described to me about how she and her sister declined to cooperate with the article?
